This has been a difficult week for most Minnesotans, since we heard of the death of Paul Wellstone. Indeed, people all over the country are mourning the loss of what one Californian called "my senator." For those who shared his liberal positions on important issues, it is especially hard, for the one voice we could depend upon to not be influenced by politics, but to speak out for what it believed, has been silenced. That strong, courageous voice gave its first and last speeches on the floor of the senate, and cast its first and last votes against the wars in Iraq.

This independent spirit was loved by nearly everyone who knew him, whether or not they agreed with his positions on issues. It is hard to see the real person during political campaigns, when the object is to vilify one's opponent in order to win the election. Certainly we saw Wellstone being attacked unmercifully during the past few months and weeks.

Strange, isn't it, how death changes people's perceptions. Paul Wellstone went from being radical rogue to honorable hero overnight. We so often do not appreciate people until they are gone. Only in their absence do we become fully aware of what they offered and how they affected our lives in important ways. If nothing else, I hope Paul's death will remind us all to tell our loved ones, and even those public figures we admire, how much we appreciate them.

Paul Wellstone will be missed--he already is. I cannot remember a politician being so widely admired and mourned since the death of President Kennedy. In this age when lists of our supposed "heroes" almost never include public servants, but are mostly sports and entertainment figures, it is refreshing to hear a politician being called a hero. He was. He represented all of the best in humanity. If only our young people would appreciate the qualities of heroism that made him the great man he was.

# DAKOTA COMMEMORATIVE MARCH

On November 7, 1862, about 1,700 Dakota Indians, mostly women and children, were forcibly marched from the Lower Sioux Agency to Fort Snelling. Two days later, over 300 condemned men were transported to Mankato, to await their execution.

This year, from Nov. 7 - 13, native Americans are planning to make a commemorative march. They will stop overnight on Nov. 8 in New Ulm. It is hoped they will be warmly received by residents, and this can be a hopeful and healing experience. They will be sleeping in Turner Hall, where they will also be served breakfast on Saturday morning before they leave.

On Friday evening, there will be a community potluck supper at Turner, to which local residents are invited. It is not known how many native Americans will come, but we are planning for about 200. Many hot dishes and other food contributions will be needed to feed them and us. If you can, plan to come and be part of this event--and bring food! Contributions are also wanted to help defray the cost of the breakfast and other expenses.

The tribes have requested a few homes for some "elders" who will be with the group. If you can offer a room or two, please let Sarah know, and she will pass it on to those in charge.
