#### A VIEW FROM THE HILL

A couple of months ago, in January, I promised that I would talk or write more about the church. Back then, I said one of the purposes of the church is to help us make sense and make meaning in this sacred life we enjoy. Religion is the framework in which we are helped "to tie together again" the disconnections we experience.

The continuing financial meltdown in the world is a significant "disconnecting" event in history affecting everyone. I do not believe I am backtracking on this New Year's resolution to you when I say that this financial and economic crisis should not pass without comment. Unlike commentators who argue what the government should or shouldn't do, my concern is for everyone's spiritual well-being, considered within the framework of religion and the purpose of the church.

The economic events of the last several months have shaken an indelible myth in the United States. That myth, in shortened form, is the belief in the soundness of our economic system. That system is now in critical condition and many millions are financially hurting as hundreds of millions of dollars in wealth has disappeared.

Humanity "seems to be unable to live without myth," so writes Alan Watts in his book, "The Wisdom of Insecurity." So our culture will have to rewrite this myth of what has been called, "American exceptionalism," a term rooted in the writings of Alexis de Tocqueville. Perhaps now the curse we've had to endure from this concept is over? I am not going to hold my breath, but I can hope.

My hope is that an epidemic of modesty occurs. When we hear politicians or other leaders talk about the greatness of the U.S., they would do so in terms of our ideals and our values, not our material wealth. When this country has realized its role in perpetuating unending warfare and a global financial meltdown, a little humility is in order.

Of course, all of this has a significant spiritual dimension. In the Sermon on the Mount, Jesus said, "As you know, what you treasure is your heart's true measure." It calls for a review of meaning, principles, and values. I look upon our seven Unitarian Universalist principles with renewed respect and a hope that perhaps there is a road map for "a way forward" to avoid the greed, pride, and arrogance that helped get us in this mess.

It is also clear to me that a renewed sense of community is paramount. People are hurting as a result of this debacle. People will need to support people, spiritually, emotionally, psychologically, and certainly, financially. It is time for a re-examination of "treasure," as Jesus so wisely said. Like repairing the economy, all of this will take time and effort, but it has to be done.

#### **RELIGIOUS EDUCATION**

The Tweeners and Association class have been discussing belief systems. We watched the DVD of

the ABC News Special "Heaven, Where Is It? How Do We Get There?" In this News Special was a series of interviews with people of differing belief systems including: Christian Evangelicals, Catholics, Jewish, Islamic, Buddhism and Atheism.

On March 15th Jason Mack spoke to the class about Buddhism. We learned a great deal from

him and were saddened to learn about the plight of the Tibetan people. A portion of the proceeds from the Easter Sunday Breakfast will be given to Tibetan Relief efforts. We plan on meeting with the Buddhist Monks in Mankato to learn more about their tradition. Jason is helping to arrange this. He has been a good teacher and we appreciate his time and efforts.

#### **News About Krisztina**

This is an update from the Partner Church Council concerning Krisztina Pall, the representative from our Romanian sister church in Benced. She visited Nora in late February. The information below is current as of 3/18/2009. Please consider making a contribution to help offset Krisztina's medical expenses and lost income. Some of you might not know this yet - Krisztina Pall suffered a terrible car accident as she was riding with her colleagues to work. She is in the hospital in Udvarhely.

I just spoke with Krisztina. She was speaking very clear English - a good sign, I think. I had been prepared to make it a very short call if I thought it was difficult at all for her to speak in English, but it seemed not to be and she seemed to want to talk.

Here is what I learned about her condition from her: She has multiple breaks in her leg/hip which was operated on. She has a broken pelvis. She has double vision which the doctors hope will clear up soon. She also had blood in her spinal column so they are keeping her flat and still in bed. They expect this will clear up soon as well. She has had no loss of feeling at all, the good news. They are predicting that she will be in bed for 3 months.

Her mother is with her all the time - she has a bed at the hospital next to Krisztina's. Her mom is caring for her and feeding her. Her brother has fixed her up with an MP3 player with lots of soothing music (and love songs Krisztina says - but nothing too energetic)

As bad as her physical shape is, her mental state is also still tramatized. The accident happened when the car she was riding in slid off the road and broke through the guard rail and plummeted 150 feet down a cliff. The police and firemen had to pry her out of the car and then lift her by ropes back up to the road. She says she can't sleep because of the nightmares she has as she remembers going down - and just as upsetting - coming back up.

She was very teary - she said she had been crying most of the day. It was snowing outside and was cold and gray. She said that was probably part of why she was crying.

I don't know if you are aware, but despite the fact that Romania has national health care, one only gets proper attention and care as a result of "gifts" and "little attention" (bribes) to the doctors, nurses, orderlies, etc. She will be immobilized for a couple of months at least and at the mercy of the hospital staff. Some of us (Cathy Cordes, Dick Ford, Eileen Higgins and other American friends) have put our heads together and will be sending a donation to cover some of her medical costs. We will be converting the total amount into LEI (Romanian currency) and transfer the money to her bank account.
